## **3. Presentation and Discussion of Proposed Regulation R092-25**

Staff of the Nevada State Board of Osteopathic Medicine (Board) will provide background on the purpose and the need for the proposed additions/revisions/amendments to Nevada Administrative Code (NAC) Chapter 633 regarding licensing provisions, continuing education requirements, and fees pertaining to anesthesiologist assistants, physician assistants, and osteopathic physicians.

Executive Director Frank DiMaggio presented the proposed regulation R092-25. The regulation was drafted to conform Nevada Administrative Code (NAC) Chapter 633 to Assembly Bill 56, passed during the 2025 Nevada Legislative session. It makes various conforming changes, including:

- Providing for biennial license renewals for certain licenses rather than annual renewals;
- Updating continuing education requirements for osteopathic physicians and physician assistants necessary for license renewals; and
- Making conforming changes to various fees charged by the Board.

Copies of the full proposed regulation R092-25, the public meeting notice, and the notice of intent to act upon the regulation were posted on the Board's website ([www.bom.nv.gov](http://www.bom.nv.gov)) for more than 30 days prior to the hearing, in accordance with Nevada law.
