### **3. Presentation and Discussion of Proposed Regulation R062-24**

Staff of the Nevada State Board of Osteopathic Medicine (Board) will provide background on the purpose and the need for the proposed revisions/amendments to Nevada Administrative Code (NAC) Chapter 633 regarding anesthesiologist assistants, physician assistants, and osteopathic physicians.

Executive Director Frank DiMaggio stated that this regulation was proposed by the Board as a result of Executive Order 2023-003, issued by the governor of the State of Nevada, Joe Lombardo, instructing agencies, commissions, and boards to review all their regulations and delete at least ten of them. The Board met and selected ten regulations to delete from the Nevada Administrative Code, Chapter 633. Executive Director DiMaggio stated the notice of intent to act as well as the agenda were published and provided in accordance with Nevada law and Nevada open meeting law.

Executive Director DiMaggio listed the following ten regulations proposed to be deleted from NAC Chapter 633:

- 1) NAC 633.273 Authorized facility licensed to practice osteopathic medicine as psychiatrist in certain mental health centers.
- 2) NAC 633.274 Authorized facility license to practice as osteopathic physician in institution of Department of Corrections.
- 3) NAC 633.380 Reports of certain information concerning surgeries, submission failure to comply with requirements.
- 4) NAC 633.410 Rulings on preliminary matters.
- 5) NAC 633.420 Appearance and representation of parties.
- 6) NAC 633.440 Proposed findings of fact and conclusions of law.
- 7) NAC 633.450 Summary suspension of license by Board.
- 8) NAC 633.454 Hearing officer or panel, authority of Board duties findings and recommendations.
- 9) NAC 633.457 Hearing officer or panel, rulings regarding admissibility of evidence referral of matter to Board.
- 10) NAC 633.466 Stipulations regarding facts in issue.
