2. Public Comment

3. Presentation and Discussion of Proposed Regulations

Staff of the Nevada State Board of Osteopathic Medicine (Board) will provide background on the purpose and the need for the proposed revisions/amendments to Nevada Administrative Code (NAC) Chapter 633, specifically NAC 633.250 regarding requirements for continuing education required for renewal of an osteopathic physician's license; NAC 633.285 regarding the period of validity of the Physician Assistant license and requirements for continuing education required for the renewal of a Physician Assistant license; and NAC 633.335 regarding various fees for licenses.

Executive Director Frank DiMaggio stated the amendments are in accordance with AB 56, passed during the 2025 Nevada Legislative Session. The effective date of these amendments are as follows: for osteopathic physicians is January 1, 2027, and for physician assistants, January 1, 2028.

Key changes include the adjustment of licensing fees from annual to biennial. The initial license fee for osteopathic physicians increased from \$500 per year to \$1,000 per biennium. The renewal fee for osteopathic physicians increased from \$350 per year to \$700 per biennium. A special event license fee was added, that being \$200.

The application and initial license fee for physician assistants increased from \$300 to \$600 biennially. The simultaneous license fee for physician assistants increased from \$150 to \$300 biennially. The renewal fee for physician assistants is now \$300 per biennium, and the simultaneous renewal fee is also \$300 per biennium.

For anesthesiologist assistants, the biennial license renewal fee is \$400, and the simultaneous renewal fee is \$200. The inactive license fee increased from \$200 to \$400.

A revision was made to the license fee reduction clause. Section A was deleted and replaced to state that a 50% fee reduction applies to applicants for initial licenses (osteopathic physicians, physician assistants, or anesthesiologist assistants) whose license will expire less than 12 months after issuance.
