**3. Presentation and Discussion of Proposed Deletions to Regulations**

Staff of the Nevada State Board of Osteopathic Medicine (Board) will provide background on the purpose and the need for the deletion of ten (10) regulations to Nevada Administrative Code (NAC) Chapter 633, pursuant to the Governor's Executive Order 2023-003.

Executive Director Frank DiMaggio stated that on January 12, 2023, Governor Lombardo issued Executive Order 2023-003 which, in relevant part, directed that the Nevada Board of Osteopathic Medicine review its regulations, which are contained in Chapter 633 of the Nevada Administrative Code ("NAC") and identify at least ten regulations for removal. There was a public hearing held on April 5, 2023, at 5:30PM by the Board and, at that hearing, public comments were requested as to the proposed ten regulations to be deleted. No comments were received either in writing or during the public hearing, and the Board considered the ten regulations in NAC Chapter 633 to be deleted in descending order of priority.

Executive Director DiMaggio stated that on the list of proposed deletions, all the regulations are contained in Chapter 633 of the NAC and he will not repeat the word “NAC” prior to each section number being proposed for deletion. He then stated that the following NAC sections were proposed for deletion as approved by the Board at the April 5, 2023 meeting:

The first section is 633.380 dealing with reports of certain information concerning surgeries; submission; failure to comply with requirements.

The second section is 633.410- rulings on preliminary matters.

The third section is 633.420- appearance and representation of parties.

The fourth section is 633.440- proposed findings of fact and conclusions of law.

The fifth section is 633.450- summary suspension of license by Board.

The sixth section is 633.454- hearing officer or panel; authority of Board; duties; findings and recommendations.

The seventh section is 633.457- hearing officer or panel; rulings regarding admissibility of evidence; referral of matter to Board.

The eighth section is 633.466- stipulation regarding facts in issue.

The ninth section is 633.273- authorized facility license to practice osteopathic medicine as psychiatrist in certain mental health centers.

The tenth section is 633.274- authorized facility license to practice as osteopathic physician in institution of Department of Corrections.

Richard Dreitzer confirmed that Executive Director DiMaggo’s list is consistent with his list.
